Polling in 4th round in Bihar

At some polling stations, members of two rival parties were seen shaking each other with violence in three rounds and were charged to bring law and order. There was a rise in communal tension, which was brought under control. SP are camping at the polling stations. The CEO said, adding reasons have been

mentioned after a while. The intervention by the District Magistrate and the Divisional Police Officer was not sufficient. The Divisional Police Officer was replaced with an SP. At polling station in East Champaran, the candidate Shivji was asked to report to the station which was replaced with CRPF personnel. The police forces, he said, were on duty in East

Champaran district. Fortynine people were arrested and 58 motorcycles and a car were seized by the authorities during the polling. Nayak said. The voting percentage in the seven districts was: West Champaran 59.17 per cent, East Champaran 59.96 per cent, Sheohar 56.05 per cent, Sitamarhi 56.09 per cent, Muzaffarpur 56.83 per cent, Gopalganj 58.90 per cent and Siwan 54.31 per cent.

Nayak said a 108-year-old woman Chhathi Devi cast her vote at booth number 177 of Govindganj seat in East Champaran district, while 105-year-old Panwa Devi exercised her franchise in Barauli constituency of Gopalganj district. A total of 776 candidates were in the fray in 55 constituencies, including 57 women. Prominent among those whose electoral fate have been sealed in electronic voting machines are senior state minister Ramai Ram (Bochaha) and former minister and Hindustani Awam Morcha leader Mahachandra Prasad Singh (Hathwa). With today's polling, voting in 186 seats has been completed in the four phases. The fifth and final round of polling would be held on November 5 for the remaining 57 seats in the 243-member Bihar Assembly. Counting will take place on November 8. (PTI)

down. Repeated attempts for tripartite meetings between the unions, tea garden owners and the government have failed as the owners never turn up for the talks," alleged Dey.

Ziaur Alam, secretary of the tea workers' union affiliated to the CITU also echoed Dey's allegations and said the state government was not doing enough to force the owners of closed tea gardens to hold talks and make efforts in reopening the gardens. (PTI) Siliguri Mayor Asok Bhattacharya today visited the Bagrakot tea garden and met the family members of Rajen Pradhan. Later on talking to reporters Bhattacharya alleged the Trinamool Congress government in the state was doing nothing to reopen the closed tea gardens. "Helipads are being constructed for the Chief Minister's helicopter to land by cutting down trees and destroying crops. A section of tea garden

owners are flying along with the CM and the helpless workers are dying of malnutrition in the closed tea gardens," said Bhattacharya. "The tea garden owners run the gardens on lease from the Central government and they are not at liberty to shut down the gardens at their free will. The state government is doing nothing to ensure that the gardens are open and salaries are paid to the workers," alleged the senior CPI(M) leader. Bijoy Chandra Barman, the TMC MP of Jalpaiguri, also visited the Bagrakot tea gardens and claimed Pradhan died due to natural illness and not malnutrition.

"The government is giving rice at Rs 2 per kg to all affected tea garden workers and Rs 1,500 to their families per month. They are also getting all government facilities and there is no malnutrition in this area," Barman said.
